**Vacancy for Post of Project Manager (Fisheries and Marine Parks)
Rodrigues Regional Assembly (Marine Parks)**

Applications are invited from qualified **Rodriguan** candidates who wish to be considered for appointment as Project Manager (Fisheries and Marine Parks) in the Rodrigues Regional Assembly (Marine Parks).

II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **40th** birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

- A.** Candidates should possess a degree in Marine Science or Marine Biology or Biology or Aquaculture or Fisheries Science or Fish Technology or Fishing Technology from a recognised institution or an equivalent qualification acceptable to the Public Service Commission.
- B.** Candidates should -
- (i) reckon at least three years' experience in the implementation of marine development projects;
 - (ii) possess good organising and leadership skills;
 - (iii) possess good communication and interpersonal skills;
 - (iv) be able to motivate a team of officers; and
 - (v) be computer literate.

NOTE

1. Candidates should produce written evidence of experience/knowledge claimed.
2. **The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities (Tertiary Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered failing the non-submission of Equivalence Certificate, as appropriate, by the closing date.**
3. The Commission reserves the right to convene **only** the best qualified candidates for interview.

IV. ROLE AND RESPONSIBILITIES

To be responsible for the development and implementation of marine projects and the overall management of marine parks in Rodrigues.

V. DUTIES AND SALARY

1. To be responsible to the Departmental Head for the proper co-ordination, supervision, monitoring and management of Marine Protected Areas Projects in Rodrigues.
2. To advise the Departmental Head on all matters relating to the development of marine protected areas in Rodrigues.
3. To identify marine reserve for development and implementation of declared marine parks in Rodrigues.
4. To prepare alternative livelihood project write-ups for financing in accordance with the requirements of funding agencies.
5. To be responsible for sensitisation and education of the fisher's community and development of alternative livelihood projects for the welfare of fishermen.
6. To conduct research on coral reefs and marine resources for development of project for regeneration of the lagoon.
7. To use ICT in the performance of his duties.
8. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Project Manager (Fisheries and Marine Parks) in the roles ascribed to him.

The permanent and pensionable post carries salary in scale Rs 26,300 x 775 – 32,500 x 925 – 37,125 x 1,225 – 40,800 x 1,525 – 49,950 x 1,625 – 56,450 a month.
