# <u>Vacancy for Post of Principal Prisons Health Service Officer (Male)</u> <u>Mauritius Prison Service</u>

Applications are invited from qualified officers of the Mauritius Prison Service who wish to be considered for appointment as Principal Prisons Health Service Officer (Male) in the Mauritius Prison Service.

## II. QUALIFICATIONS

By selection from among officers in the grade of Senior Prisons Health Service Officer (Male) who reckon at least two years' service in a substantive capacity in the grade and who -

- (i) possess good administrative and organising abilities;
- (ii) have a good personality and leadership qualities; and
- (iii) are capable of dealing with crisis situation.

### III. ROLE AND RESPONSIBILITIES

To be responsible for the effective management of the health service of the respective unit such that detainees are provided with a comprehensive health care.

### IV. DUTIES AND SALARY

- 1. To be responsible for
  - (a) the supervision and day-to-day running of the Beau Bassin Prison Hospital and dispensaries at all penal institutions;
  - (b) the pharmacy of the health service of the Prison and the preparation and/or issue of medicines and drugs to all penal institutions;
  - (c) the carrying out of treatment prescribed by the Medical and Health Officer/Senior Medical and Health Officer at Beau Bassin Prison;
  - (d) the regular weighing of detainees;
  - (e) the keeping of all ledgers and vouchers up-to-date; and
  - (f) the submission of a monthly and an annual return to the Commissioner of Prisons through the Head, Prisons Health Service.

- 2. To assist the Head, Prisons Health Service in the performance of his duties.
- 3. To ensure that all directives given by the Medical and Health Officer/Senior Medical and Health Officer or Head, Prisons Health Service are carried out.
- 4. To perform such other duties as are laid down in the Reform Institutions Act, Prison Regulations and legislations in force.
- 5. To ensure that appropriate orders, directives are adhered to for the smooth running of the health service of the Mauritius Prison Service.
- 6. To maintain high nursing and hygienic norms.
- 7. To be responsible for the organisation of rehabilitation and support programmes for substance abusers and detainees living with HIV/AIDS.
- 8. To plan, allocate and co-ordinate the work of subordinate staff.
- 9. To ensure the optimum use of resources.
- 10. To use ICT in the performance of his duties.
- 11. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Principal Prisons Health Service Officer (Male) in the roles ascribed to him.

The permanent and pensionable post carries salary in the scale Rs 37,450 x  $950 - 42,200 \ge 1,300 - 46,100 \ge 1,575 - 49,250 \ge 1,650 - 54,200 \ge 1,700 - 62,700$  a month.
