- (1)The Application Form should be completed in the candidate's own handwriting and forwarded to the Secretary, Disciplined Forces Service Commission, 7, Louis Pasteur Street, Forest Side.
- (2)It is very important for the candidate to indicate his National Identity Number in the space provided at item 2 of the Application Form.
- Care should be taken to fill in the Application Form correctly. Incomplete, inadequate (3)or inaccurate filling of the Application Form may entail a candidate's elimination. It is an offence to give information which is false or to conceal any relevant information. This
 - may lead to an application being rejected or, if a candidate has already been appointed, to the
- termination of his appointment. (4)Qualifications obtained after the closing date for the submission of applications as specified in
- the advertisement **will not** be accepted. Only qualified persons should apply.
- (5)Applications not made on the prescribed form **will not** be accepted.
- (6)Applications received after the closing date and time mentioned in the advertisement will
- not be accepted. The onus for the prompt submission of applications so that they reach the Secretary of the Commission in time lies solely on applicants.
