# Vacancy for Post of Community Health Development Motivator Ministry of Health and Wellness

Applications are invited from qualified candidates who wish to be considered for appointment as Community Health Development Motivator in the Ministry of Health and Wellness.

#### II. <u>AGE LIMIT</u>

Candidates, unless already in the Service, should not have reached their <u>40</u><sup>th</sup> birthday by the closing date for the submission of applications.

### III. QUALIFICATIONS

Candidates should -

- (a) possess a Cambridge School Certificate <u>or</u> have obtained passes on one certificate at the General Certificate of Education "Ordinary Level" either
  (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grade C in any one subject <u>or</u> an equivalent qualification acceptable to the Public Service Commission;
- (b) possess at least two years' experience in social work; and
- (c) be computer literate.

# <u>NOTE</u>

- 1. Candidates should produce written evidence of experience/knowledge claimed.
- 2. The for the submission of written evidence onus of experience/knowledge claimed and equivalence of qualification (if the relevant authorities (Higher applicable) from Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of nonsubmission of written evidence of experience/knowledge claimed and Equivalence of Certificate, as appropriate, by the closing date.
- 3. Candidates may be required to sit for a written examination as part of the selection process.

- 4. The Commission reserves the right:
  - (i) to convene **<u>only</u>** the best qualified candidates for interview; and
  - (ii) not to make any appointment following this advertisement.

# IV. DUTIES AND SALARY

- 1. To be responsible to the Health Promotion Co-ordinator for
  - (i) promoting community participation/involvement in the field of primary health care, including communicable and non-communicable diseases through sensitisation campaigns, talks, seminars and regular meetings;
  - (ii) organising community health campaigns, activities and programmes;
  - (iii) liaising with members of local Health Committees/Non Govermental Organisations, "Forces Vives" Community leaders and other Health stakeholders for the organisation of community-based health activities;
  - (iv) helping the community in identifying its health needs;
  - (v) undertaking home/site visits for the promotion of community health activities relating to both communicable and non-communicable diseases; and
  - (vi) keeping record/statistics, preparing and submitting progress reports and returns as required.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Community Health Development Motivators in the roles ascribed to them.

Community Health Development Motivators will be required to work after normal working hours, including Sundays and Public Holidays.
