Vacancy for Post of Laboratory Technician
Rodrigues Regional Assembly (Water Resources)

Applications are invited from qualified **Rodriguan** candidates who wish to be considered for appointment as **Temporary** Laboratory Technician in the Rodrigues Regional Assembly (Water Resources).

II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **40th** birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

Candidates should –

- A. possess a Cambridge Higher School Certificate with a pass at “Principal Level” in Chemistry or Physics or Passes in at least two subjects including Chemistry or Physics obtained on one certificate at the General Certificate of Education “Advanced Level” or an equivalent qualification acceptable to the Public Service Commission.
- B. be computer literate.

NOTE

1. Candidates should produce written evidence of knowledge claimed.
2. **The onus for the submission of written evidence of knowledge claimed and equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.**
3. Candidates may be required to sit for a written examination as part of the selection process.
4. The Commission reserves the right:-
 - (i) to convene **only** the best qualified candidates for interview; and
 - (ii) not to make any appointment following this advertisement.

IV. DUTIES AND SALARY

1. To be responsible for the care and maintenance of the laboratory and equipment.
2. To assist in the collection of samples and chemical and biological analysis of water samples, the calculation of results, plotting of graphs and the writing up of the reports.
3. To keep record of all laboratory equipment in an inventory register.
4. To use ICT in the performance of his duties.
5. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Laboratory Technician in the roles ascribed to him.

The permanent and pensionable post carries salary in scale Rs 16,725 x 325 – 17,700 x 375 – 19,575 x 475 – 21,950 x 625 – 23,200 x 775 – 32,500 x 925 – 35,275 a month.

Appointment in a temporary capacity in the grade carries a flat salary of Rs 16,725 a month.

V. MODE OF APPLICATION

Care should be taken to fill in the Application Form correctly. **Incomplete, inadequate or inaccurate filling of the Application Form may entail elimination of the candidate.**

Application Forms should reach the Island Chief Executive, Chief Commissioner's Office, Port Mathurin, Rodrigues, **not later than 3.15 p.m. (local time) on Thursday 18 February 2021.** Application Forms received after the specified closing date and time will **not** be considered.
