Applications are invited from qualified candidates who wish to be considered for appointment as Town and Country Planning Officer in the Ministry of Housing and Land Use Planning.

II AGE LIMIT

Candidates, unless already in the Service, should not have reached their **40th** birthday by the closing date for the submission of applications.

III QUALIFICATIONS

Candidates should -

- **A.** possess a degree in Town and Country Planning from a recognised institution <u>or</u> an equivalent qualification acceptable to the Public Service Commission; and
- **B.** be computer literate.

<u>NOTE</u>

- 1. Candidates should produce written evidence of knowledge claimed.
- 2. The onus for the submission of written evidence of knowledge claimed and equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 3. Candidates may be required to sit for a written examination as part of the selection process.
- 4. The Commission reserves the right:
 - (i) to convene **only** the best qualified candidates for interview; and
 - (ii) not to make any appointment following this advertisement.

IV DUTIES AND SALARY

- 1. To participate in the preparation and revision of development plans at all spatial levels.
- 2. To advise on matters relating to land use.
- 3. To replace the Senior Town and Country Planning Officer, as and when required.
- 4. To use ICT in the performance of his duties.
- 5. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Town and Country Planning Officer in the roles ascribed to him.

The permanent and pensionable post carries salary in scale Rs 29,400 x 775 – 32,500 x 925 – 37,125 x 1,225 – 40,800 x 1,525 – 49,950 x 1,625 – 56,450 a month.
