# <u>Vacancies for Post of Specialist/Senior Specialist</u> Ministry of Health and Wellness

Applications are invited from qualified candidates who wish to be considered for appointment as Specialist/Senior Specialist **in the field of Anaesthesia** in the Ministry of Health and Wellness.

## II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **40**<sup>th</sup> birthday by the closing date for the submission of applications.

### III. QUALIFICATIONS

Candidates should:-

- (i) be fully registered
  - (a) as medical practitioner in accordance with section 22 of the Medical Council Act; and
  - (b) as specialist in accordance with section 23 of the Medical Council Act, in the field of Anaesthesia.
- (ii) be able to communicate effectively and to interact with people at all levels.

- 1. Specialist/Senior Specialists shall be known as Consultant in their respective fields on reaching salary point Rs 86,000.
- 2. Candidates should submit a copy of their Certificate of Registration as medical practitioner and as specialist in Mauritius together with their Application Form.
- 3. Candidates may be required to take part in a written examination.

#### IV. ROLE AND RESPONSIBILITIES

To be responsible for the provision of an effective and efficient clinical service in his speciality.

#### V. DUTIES AND SALARY

- 1. To be responsible to the Regional Health Director through the Consultant-in-Charge of the relevant field for the following: -
  - (i) to perform clinical and other work pertaining to his speciality;
  - (ii) to mentor and train junior medical, nursing and other health personnel;
  - (iii) to initiate and participate in surveys and research activities and publications; and
  - (iv) to contribute to the development of health programmes.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Specialists/Senior Specialists in the roles ascribed to them.

The permanent and pensionable post carries salary in scale Rs  $59,700 \times 1,625 - 62,950 \times 1,850 - 68,500 \times 1,950 - 74,350 \times 2,825 - 80,000 \times 3,000 - 95,000$  a month.

## VI. FRINGE BENEFITS
