Applications are invited from qualified officers of the Rodrigues Regional Assembly who wish to be considered for appointment as Internal Control Officer/Senior Internal Control Officer in the Rodrigues Regional Assembly (Central Administration).

II. QUALIFICATIONS

By selection from among serving officers on the establishment of the Rodrigues Regional Assembly who hold a substantive appointment and who -

(i) have successfully completed all papers of Fundamentals (Knowledge) and Paper F4 of Fundamentals (Skills) of the ACCA Examinations

or

(ii) have obtained the Certificate in Business Accounting (Foundation Level) of the CIMA Examinations (New Syllabus)

or

(iii) possess equivalent qualifications to (i) and (ii) above acceptable to the Public Service Commission.

NOTE

The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of Equivalence Certificate, as appropriate, by the closing date.

III. DUTIES AND SALARY

- 1. To carry out internal audit in finance, stores, transport and other operations of Commissions in accordance with internal audit programmes and procedures.
- 2. To maintain adequate documentations and records of work performed, including daily progress sheets.
- 3. To prepare and update working paper files.
- 4. To assist in the framing of internal audit programmes.

- 5. To report on internal audit findings and propose corrective measures.
- 6. review internal audit reports and to that the ensure recommendations made on audit findings are satisfactorily implemented.
- 7. To use ICT in the performance of his duties.
- 8. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Internal Control Officer/Senior Internal Control Officer in the roles ascribed to him.

The permanent and pensionable post carries salary in scale Rs $19,850 \times 325 - 21,475 \times 375 - 22,225 \times 400 - 23,425 \times 525 - 26,050 \times 675 - 27,400 \times 825 - 35,650 \times 900 - 37,450 \times 950 - 42,200 \times 1,300 - 46,100$ a month.
