Vacancy for Post of Principal Health Engineering Officer <u>Ministry of Health and Wellness</u>

Applications are invited from qualified officers of the Ministry of Health and Wellness who wish to be considered for appointment as Principal Health Engineering Officer in the Ministry.

II. QUALIFICATIONS

By selection from officers in the grade of Senior Health Engineering Officer reckoning at least three years' service in a substantive capacity in the grade.

III. DUTIES AND SALARY

To be responsible to the Director, Environmental Health Engineering Unit through the Lead Sanitary Engineer in the region for the following: -

- 1. To give assistance in the organisation, planning, and execution of the activities of the Environmental Health Unit.
- 2. To plan and monitor the work of the Senior Health Engineering Officer and subordinates in the region.
- 3. To assist the different sections of the Ministry, officers of other Ministries and parastatal bodies on matters regarding sanitary engineering and environmental pollution control.
- 4. To investigate on problems relating to sanitary engineering, environmental pollution, industrial health and to advise on environmental control measures.
- 5. To assist in the water quality control in the region and in the distribution of potable water to the public so as to protect them from health hazards.
- 6. To represent the Ministry on committees relating to issues on protection and management of environmental health.
- 7. To assist in the drafting review and consolidation of legislations regarding Public Health and Environmental Health.
- 8. To examine building plans regarding Government projects for the purpose of grant of health clearance.

- 9. To assist the inter-ministerial Committee dealing with the grant of permits for industrial, hotel, and development projects and to submit reports whenever necessary.
- 10. To conduct site visits and assist in drafting of reports on Environmental Impact Assessment in accordance with the provisions of the Environmental Protection Act.
- 11. To prepare and submit monthly returns of the activities in the regions under his supervision.
- 12. To perform such cognate duties as may be assigned.

The permanent and pensionable post carries salary in scale Rs $44,800 \times 1,300 - 46,100 \times 1,575 - 49,250 \times 1,650 - 54,200 \times 1,700 - 64,400 \times 1,800 - 69,800 \times 2,000 - 73,800$ a month.
