<u>Vacancy for Post of Transcriber</u> <u>Ministry of Labour, Human Resource Development and Training</u> (Labour Division)

Applications are invited from qualified candidates who wish to be considered for appointment as Transcriber (*formerly* Shorthand Writer) in the Ministry of Labour, Human Resource Development and Training (Labour Division).

II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **45th** birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

Candidates should possess -

A. a Cambridge School Certificate with credit in at least English Language and French obtained on one certificate <u>or</u> Passes in at least five subjects with at least Grade C in English Language and French obtained on one certificate at the General Certificate of Education "Ordinary Level" <u>or</u> an equivalent qualification acceptable to the Public Service Commission.

<u>Note</u>

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at "Principal Level" and one subject at "Subsidiary Level" as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

- **B.** a certificate in English Shorthand of 100 words a minute or in French Shorthand of 80 words a minute from a recognised institution.
- **C.** a certificate in keyboarding or typewriting at a speed of at least 25 words per minute from a recognised institution.

NOTE 1

Senior Word Processing Operators and officers who hold a substantive appointment in the grade of Word Processing Operator will also be considered provided they possess the qualification at \mathbf{B} above.

NOTE 2

Candidates not possessing the qualification at C above will also be considered provided they can type/operate a keyboard efficiently at a speed of at least 25 words a minute. They will be required to undergo a test as arranged by the Public Service Commission.

NOTE

- 1. The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of Equivalence Certificate, as appropriate, by the closing date.
- 2. Candidates should submit a copy of the qualifications at **B** and **C** together with their Application Form.
- 3. Candidates may be required to take part in a written examination.
- 4. The Commission reserves the right:
 - (i) to convene **only** the best qualified candidates for interview; and
 - (ii) not to make any appointment following this advertisement.

IV. DUTIES AND SALARY

- 1. To take down shorthand notes of debates, proceedings and meetings both in English and French and to transcribe them.
- 2. To give clerical, typing and secretarial assistance, as and when required.
- 3. To train Senior Word Processing Operators and Word Processing Operators, as and when required.
- 4. To perform word processing and other basic ICT functions.
- 5. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Transcriber in the roles ascribed to him.

<u>Note</u>

Transcribers may be required to work at staggered hours.

The permanent and pensionable post carries salary in scale Rs $23,025 \times 400 - 23,425 \times 525 - 26,050 \times 675 - 27,400 \times 825 - 35,650 \times 900 - 37,450 \times 950 - 42,200 \times 1,300 - 44,800$ a month.

V. MODE OF APPLICATION
