Enlistment as Trainee Assistant Inspector of Works
Rodrigues Regional Assembly (Public Infrastructure)

Applications are invited from qualified **Rodriguan** candidates who wish to be considered for enlistment as Trainee Assistant Inspector of Works in the Rodrigues Regional Assembly (Public Infrastructure).

II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **45th** birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

Candidates should –

- A. possess a Cambridge School Certificate with credit in at least five subjects including English Language, French and Mathematics or Principles of Accounts obtained on one certificate or passes not below Grade C in at least five subjects including English Language, French and Mathematics or Principles of Accounts obtained on one certificate at the General Certificate of Education “Ordinary Level” or an equivalent qualification acceptable to the Public Service Commission.

Note

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at “Principal Level” and one subject at “Subsidiary Level” as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

- B. be computer literate.

NOTE

1. Candidates should produce written evidence of knowledge claimed.
2. **The onus for the submission of written evidence of knowledge claimed and equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.**

3. Candidates may be required to take part in a written examination.
4. The Commission reserves the right:
 - (i) to convene **only** the best qualified candidates for interview; and
 - (ii) not to make any enlistment following this advertisement.

IV. CONDITIONS OF TRAINING AND ALLOWANCE

Selected candidates will be required to undergo two years on-the-job training, both theoretical and practical, in all aspects of the work of an Assistant Inspector of Works at the end of which Trainee Assistant Inspectors of Works will be required to undergo a work-oriented examination.

During the training period, Trainee Assistant Inspectors of Works will draw an allowance in scale Rs 16,005 x 260 – 16,525 a month.

On successful completion of the training, Trainee Assistant Inspectors of Works will be considered for appointment to the grade of Assistant Inspector of Works, as and when vacancies occur.

The post of Assistant Inspector of Works carries salary in scale Rs 17,305 x 260 – 17,825 x 275 – 18,925 x 300 – 19,525 x 325 – 21,475 x 375 – 22,225 x 400 – 23,425 x 525 – 26,050 x 675 – 27,400 x 825 – 35,650 x 900 – 36,550 a month.

V. BOND

The selected candidates will be given a moratorium period of one month to allow them to make an informed decision before committing into signing a bond agreement (which will start as from the date of enlistment) together with two or more sureties in the sum of **four hundred and fifty-five thousand nine hundred and ten rupees (Rs 455,910)** to the effect that they will follow and complete the training and serve the Public Infrastructure Division of the Rodrigues Regional Assembly for a period of three years as from the date of appointment as Assistant Inspector of Works.

VI. MODE OF APPLICATION

1. Qualified candidates should submit their application on **PSC Form 7** which may be obtained **either** from the Enquiry Counter of the Ministry of Public Service, Administrative and Institutional Reforms, Ground Floor, Emmanuel Anquetil Building, Port Louis **or** from the Enquiry Counter of the Public Service Commission, 7, Louis Pasteur Street, Forest Side **or** from the Chief Commissioner's Office, Port Mathurin, Rodrigues **or** from the offices of the Mauritius High Commissions/Embassies overseas.

3. Acknowledgement of applications will be made, as far as possible, by **e-mail**. Candidates are, therefore, advised to submit their e-mail address.
4. Candidates are also advised to read carefully the **“NOTES AND INSTRUCTIONS TO CANDIDATES”** before filling in the Application Form. Care should be taken to fill in the Application Form correctly. **Incomplete, inadequate or inaccurate filling of the Application Form may entail elimination of the candidate.**

VII. CLOSING DATE

Application Forms should reach the Island Chief Executive, Chief Commissioner's Office, Port Mathurin, Rodrigues, **not later than 15 15 hours (local time) on Thursday 03 August 2023**. Application Forms received after the specified closing date and time will **not** be considered.

IMPORTANT

The post which falls under the Establishment of the Rodrigues Regional Assembly is restricted for service in Rodrigues only. Any request for transfer or promotion to any similar or other posts in Mauritius will not be considered at any stage from any person who is selected for enlistment.
