Vacancy for the Post of Agricultural Engineer Ministry of Agro-Industry and Food Security

Applications are invited from qualified candidates who wish to be considered for appointment as Agricultural Engineer in the Ministry of Agro-Industry and Food Security.

II. <u>AGE LIMIT</u>

Candidates, unless already in the Service, should not have reached their **45th** birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

Candidates should -

- be registered as Professional Engineer (Agricultural Engineering or Mechanical Engineering or Civil Engineering) with the Council of Registered Professional Engineers of Mauritius under section 13 of Act No. 49 of 1965, as subsequently amended; and
- (ii) be computer literate.

NOTE

- 1. Candidates should produce written evidence of knowledge claimed.
- 2. Candidates should submit a copy of their Certificate of Registration as Professional Engineer together with their Application Form.
- 3. The onus for the submission of written evidence of knowledge claimed rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge claimed, by the closing date.
- 4. Candidates may be required to take part in a written examination.
- 5. The Commission reserves the right:
 - (i) to convene only the best qualified candidates for interview; and
 - (ii) not to make any appointment following this advertisement.

IV. DUTIES AND SALARY

- 1. To be responsible to the Principal Agricultural Engineer through the Senior Agricultural Engineer for the performance of the following -
 - (a) to plan and execute engineering works assigned to him;

- (b) to organise and supervise the work of Senior Technical Officers, Technical Officers and other technical staff in the Agricultural Engineering Division; and
- (c) to design farm structures, irrigation and drainage system in connection with agriculture.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Agricultural Engineers in the roles ascribed to them.

The permanent and pensionable post carries salary in scale Rs 33,175 x 825 – 35,650 x 900 – 37,450 x 950 – 42,200 x 1,300 – 46,100 x 1,575 - 49,250 x 1,650 – 54,200 x 1,700 – 62,700 a month.

V. <u>FRINGE BENEFITS</u>

The Agricultural Engineer is entitled to the following benefits: -

- (a) 100% duty exemption for the purchase of a car with engine capacity of up to 1,500 c.c. once every seven years <u>or</u> a monthly car allowance of Rs 3,980 in lieu of duty exemption;
- (b) loan facilities of up to 21 months' salary refundable in 84 monthly instalments at the interest rate of 3% per annum in respect of a first purchase of a duty exempted car and 1% per annum in respect of a first purchase of an electric car;
- (c) a monthly travelling allowance of Rs 13,200 both for attending duty and for official travelling;
- (d) passage benefits at the rate of 5% of annual salary drawn; and
- (e) refund of the full amount of annual subscription fee payable to the Council of Registered Professional Engineers of Mauritius.
