# <u>Vacancy for Post of Medical Physicist/Senior Medical Physicist</u> <u>Ministry of Health and Wellness</u>

Applications are invited from qualified candidates who wish to be considered for appointment as Medical Physicist/Senior Medical Physicist in the Ministry of Health and Wellness.

# II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their <u>45<sup>th</sup></u> birthday by the closing date for the submission of applications.

# III. QUALIFICATIONS

Candidates should -

- A. possess a Cambridge Higher School Certificate with passes at Principal Level in at least two subjects including one Science subject obtained on one certificate or Passes in at least two subjects including one Science subject obtained on one certificate at the General Certificate of Education "Advanced Level".
- B. possesss a degree in Physics or Medical Physics from a recognised institution.

OR

Equivalent qualifications to A and B above acceptable to the Public Service Commission.

C. be computer literate.

## Note

Qualification at A above should have been obtained prior to qualification at B above. However, candidates who, as at 30 June 2003, did not possess the qualification at A above, will also be considered provided they hold –

- (a) a Cambridge School Certificate <u>or</u> Passes obtained on one certificate at the General Certificate of Education "Ordinary Level" either (i) in five subjects including English Language with at least Grade C in any two subjects or (ii) in six subjects including English Language with at least Grace C in any one subject <u>or</u> an equivalent qualification acceptable to the Public Service Commission; and
- (b) a Master's Degree or a postgraduate diploma from a recognised institution in one of the fields at B above <u>or</u> an equivalent qualification acceptable to the Public Service Commission.

Qualification at (a) under 'Note' should have been obtained prior to qualification at B above and at (b) under 'Note'.

# NOTE

Selected candidates may be required to follow a postgraduate training course in Medical Physics at a recognised institution.

# Note

- 1. The onus for the submission of equivalence of qualifications (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of Equivalence Certificate, as appropriate, by the closing date.
- 2. Candidates may be required to take part in a written examination.
- 3. The Commission reserves the right:
  - (i) to convene **only** the best qualified candidates for interview; and
  - (ii) not to make any appointment following this advertisement.

# IV. DUTIES AND SALARY

- 1. To be responsible to the Principal Medical Physicist for:-
  - (a) working in close collaboration with the Radiotherapist in planning the treatment of patients;
  - (b) dosimetry and quality assurance of equipment used in medical diagnosis and therapy as well as in other fields;
  - (c) carrying out investigations on patients in the field of medical physics as required;
  - (d) carrying out radiation surveys within the Ministry, whenever required;
  - (e) brachytherapy computerised treatment planning including the use of the Brachytherapy machine;
  - (f) manipulating and preparing radiation sources used in interstitial implants, dosimetry and calculations;
  - (g) dispensing radioactive substances to patients; and
  - (h) training of staff, as and when required.
- 2. To perform all IT related duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Medical Physicist/Senior Medical Physicists in the roles ascribed to them.

The permanent and pensionable post carries salary in scale Rs  $28,225 \times 825 - 35,650 \times 900 - 37,450 \times 950 - 42,200 \times 1,300 - 46,100 \times 1,575 - 49,250 \times 1,650 - 54,200 \times 1,700 - 64,400 \times 1,800 - 69,800$  a month.
