<u>Vacancies for Post of Physiotherapy Assistant</u> <u>Rodrigues Regional Assembly (Health)</u>

Applications are invited from qualified **Rodriguan** candidates who wish to be considered for appointment as Physiotherapy Assistant in a temporary capacity in the Rodrigues Regional Assembly (Health).

II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **45**th birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

A. Candidates should possess a Cambridge School Certificate with credit in at least five subjects including English Language, Mathematics or Principles of Accounts and two Science subjects obtained on one certificate or Passes not below Grade C in at least five subjects including English Language, Mathematics or Principles of Accounts and two Science subjects obtained on one certificate at the General Certificate of Education "Ordinary Level" or an equivalent qualification acceptable to the Public Service Commission.

Note

Candidates not possessing a credit in English Language at the Cambridge School Certificate will also be considered provided they possess passes in at least two subjects at "Principal Level" and one subject at "Subsidiary Level" as well as the General Paper obtained on one certificate at the Cambridge Higher School Certificate Examinations.

B. Candidates should -

- (i) possess good communication and interpersonal skills;
- (ii) have a good working attitude; and
- (iii) be computer literate.

Note

1. Candidates should produce written evidence of knowledge claimed.

- 2. The onus for the submission of written evidence of knowledge claimed and equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 3. Candidates may be required to take part in a written examination.
- 4. The Commission reserves the right:-
 - (i) to convene **only** the best qualified candidates for interview; and
 - (ii) not to make any appointment following this advertisement.

NOTE

Selected candidates will be appointed in a temporary capacity in the first instance and will be required to undergo training for a period of at least one year in Mauritius, as approved and arranged by the Ministry of Health and Wellness. On successful completion of the training, they will be considered for appointment as Physiotherapy Assistant in a substantive capacity.

IV. DUTIES AND SALARY

- 1. To be responsible to the Nursing Administrator (Male) for
 - (a) providing physiotherapeutic treatments in any hospital or other health institution under the supervision of a registered medical practitioner; and
 - (b) supervising, observing and reporting on patients undergoing rehabilitation exercise.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Physiotherapy Assistant in the roles ascribed to him.

The permanent and pensionable post carries salary in scale Rs $16,525 \times 260 - 17,825 \times 275 - 18,925 \times 300 - 19,525 \times 325 - 21,475 \times 375 - 22,225 \times 400 - 23,425 \times 525 - 26,050 \times 675 - 27,400 \times 825 - 34,825$ a month.

Appointment in a temporary capacity in the grade carries a flat salary of Rs 16,525 a month.

V. MODE OF APPLICATION
