<u>Vacancies for Post of Emergency Physician</u> <u>Ministry of Health and Wellness</u>

Applications are invited from qualified candidates who wish to be considered for appointment as Emergency Physician in the Ministry of Health and Wellness.

II. <u>AGE LIMIT</u>

Candidates, unless already in the Service, should not have reached their $\underline{45^{th}}$ birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

Candidates should -

- (i) be fully registered as medical practitioners in accordance with legislation in force in Mauritius;
- (ii) reckon at least three years' experience as a medical practitioner in a recognised health institution;
- (iii) possess a diploma in Emergency Medicine from a recognised institution <u>or</u> an equivalent qualification acceptable to the Public Service Commission; and
- (iv) be computer literate.

<u>NOTE</u>

1. Candidates should produce written evidence of experience/knowledge claimed.

2. <u>Candidates should submit a copy of their Certificate of</u> <u>Registration as medical practitioner in Mauritius together with</u> <u>their Application.</u>

- 3. The onus for the submission of written evidence of experience/knowledge claimed and equivalence of qualifications (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience/knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 4. Candidates may be required to take part in a written examination.
- 5. The Commission reserves the right not to make any appointment following this advertisement.

IV. DUTIES AND SALARY

- 1. To be responsible to the Regional Health Director through the Director, Emergency Services for –
 - (i) performing clinical work;
 - (ii) providing emergency medical care and treatment to patients at their home/site of accident/workplace, during trips to hospitals in the equipped ambulances and carrying out the inter hospital transfers of severely ill patients needing continuous medical support;
 - (iii) working as "Médecin Régulateur" at the Control Room of the Emergency Medical Service Unit;
 - (iv) assisting the Specialist/Senior Specialist in the field of Anaesthesia during theatre sessions and in high dependency wards or I.C.U and attending to patients in the Accident and Emergency Unit, whenever required;
 - (v) participating in the training of health personnel in the field of Emergency Medicine; and
 - (vi) participating in research activities and audit for the development and improvement of the Emergency Medical Services.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Emergency Physician in the roles ascribed to him.

Note

Emergency Physicians will be required to provide a 24-hour coverage of the Emergency Medical Service Unit, on a roster basis.

The permanent and pensionable post carries salary in scale Rs 47,675 x $1,575 - 49,250 \ge 1,650 - 54,200 \ge 1,700 - 64,400 \ge 1,800 - 69,800 \ge 2,000 - 75,800 \ge 2,150 - 82,250 \ge 3,000 - 88,250 \ge 3,125 - 91,375$ a month.

V. FRINGE BENEFITS

Emergency Physicians are entitled to the following benefits:

(a) 100% duty remission for the purchase of a car with engine capacity of up to 1500 c.c. once every seven years; <u>or</u>

a monthly car allowance of Rs 3,980 in lieu of duty remission;

- (b) loan facilities for the first purchase of a car equivalent to 21 months' salary with interest at the rate of 3% per annum, refundable in 84 monthly instalments;
- (c) a monthly travelling allowance of Rs 13,200 <u>or</u> refund of mileage at approved rate together with a monthly commuted allowance of Rs 3,260 in case officers perform official travelling during the month;
- (d) passage benefits at the rate of 5% of the annual salary drawn;
- (e) an annual allowance of Rs 13,500 for the purchase of Medical books, etc.;
- (f) an annual allowance of Rs 12,130, cumulative over a period of three years to meet the expenses towards Continuing Professional Development;
- (g) refund of the full amount of annual subscription fee payable to the Medical Council of Mauritius; and
- (h) rent free telephone and free calls.
