

## **PUBLIC SERVICE COMMISSION CIRCULAR NOTE NO. 26 OF 2025**

### **Vacancy for Post of Chief Road Transport Inspector** **National Land Transport Authority** **Ministry of Land Transport**

Applications are invited from qualified officers of the National Land Transport Authority who wish to be considered for appointment as Chief Road Transport Inspector in the National Land Transport Authority of the Ministry of Land Transport.

## **II. QUALIFICATIONS**

- I. By selection from among officers in the grades of -
- (a) Principal Road Transport Inspector who reckon at least two years' service in a substantive capacity in the grade or an aggregate of at least eight years' service in a substantive capacity in the grades of Principal Road Transport Inspector and Senior Road Transport Inspector (on roster);

AND

- (b) Senior Road Transport Inspector (on roster) who reckon at least eight years' service in a substantive capacity in the grade.
- II. Candidates should -
- (i) possess an Advanced Diploma in Transport or in Logistics and Transport from a recognised institution or an equivalent qualification acceptable to the Public Service Commission;
  - (ii) have sound administrative ability and possess strong organising skills;
  - (iii) be trustworthy and have good ethical conduct; and
  - (iv) be able to lead and motivate a team of officers.

### **NOTE**

**The onus for the submission of equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of Equivalence Certificate, as appropriate, by the closing date.**

## **III. ROLE AND RESPONSIBILITIES**

To provide technical advice in the design and implementation of policies relating to road transport matters in line with the goals and objectives of the National Land Transport Authority.

#### **IV. DUTIES AND SALARY**

1. To be responsible to the Transport Controller for the performance of the following duties -
  - (a) to look after the general administration and management of the Inspectorate Section and the overall planning of road transport inspections;
  - (b) to enforce the relevant legislation/provisions of the Road Traffic Act and conditions attached to licences;
  - (c) to compile and update statistics related to road transport;
  - (d) to prepare and vet case files for submission to the Police Department;
  - (e) to prepare draft legislation in connection with road transport matters and other related issues for consideration by the State Law Office;
  - (f) to process applications for judicial reviews and legal notices and to swear affidavits on behalf of the Authority or the Road Transport Commissioner; and
  - (g) to represent the National Land Transport Authority in meetings and committees and to liaise with other organisations, as and when required.
2. To use ICT in the performance of his duties.
3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Chief Road Transport Inspector in the roles ascribed to him.

#### **Note**

Chief Road Transport Inspectors may be required to work outside normal working hours, including Saturdays, Sundays and Public Holidays.

The permanent and pensionable post carries salary in scale Rs 39,350 x 950 – 42,200 x 1,300 – 46,100 x 1,575 – 49,250 x 1,650 – 54,200 x 1,700 – 64,400 x 1,800 – 66,200 a month.
