# II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **50**<sup>th</sup> birthday by the closing date for the submission of applications.

## III. QUALIFICATIONS

Candidates should:-

- (i) be fully registered -
  - (a) as medical practitioner in accordance with section 22 of the Medical Council Act; and
  - (b) as specialist in accordance with section 23 of the Medical Council Act, in the relevant fields of speciality.
- (ii) be able to communicate effectively and to interact with people at all levels.

#### NOTE

- 1. Specialist/Senior Specialists shall be known as Consultant in their respective fields on reaching salary point Rs 94,500.
- 2. Candidates should submit a copy of their Certificate of Registration as medical practitioner and as specialist in Mauritius together with their Application Form.
- 3. Candidates may be required to take part in a written examination.
- 4. The Commission reserves the right not to make any appointment following this advertisement.

# IV. ROLE AND RESPONSIBILITIES

To be responsible for the provision of an effective and efficient clinical service in his speciality.

### V. DUTIES AND SALARY

- 1. To be responsible to the Regional Health Director through the Consultant-in-Charge of the relevant field for the following:-
  - (i) to perform clinical and other work pertaining to his speciality;
  - (ii) to mentor and train junior medical, nursing and other health personnel;
  - (iii) to initiate and participate in surveys and research activities and publications; and
  - (iv) to contribute to the development of health programmes.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from Specialist/Senior Specialists in the roles ascribed to them.

The permanent and pensionable post carries salary in scale Rs  $64,400 \times 1,800 - 69,800 \times 2,000 - 75,800 \times 2,150 - 82,250 \times 3,000 - 88,250 \times 3,125 - 103,875 a month.$ 

### VI. FRINGE BENEFITS

Specialist/Senior Specialists are entitled to the following benefits:

(a) 100% duty remission for the purchase of a car with engine capacity of up to 1601 c. c. once every five years;

- (b) loan facilities for the first purchase of a car equivalent to 21 months' salary with interest rate at 3% per annum, refundable in 84 monthly instalments;
- (c) a monthly travelling allowance of Rs 13,200 both for attending duty and for official travelling;
- (d) passage benefits at the rate of 5% of annual salary drawn;
- (e) an allowance of Rs 13,500 annually for the purchase of medical books, e-materials, journals and other publications;
- (f) refund of the full amount of annual subscription fee payable to the Medical Council of Mauritius;
- (g) an allowance of Rs 12,130 annually, cumulative over a period of three years, to meet the expenses towards the Continuing Professional Development; and
- (h) rent free telephone and a pre-determined number of free calls depending on posting and speciality.
