Applications are invited from qualified candidates who wish to be considered for appointment as Legal Research Officer/Senior Legal Research Officer in the Attorney-General's Office.

II. AGE LIMIT

Candidates, unless already in the Service, should not have reached their **45**th birthday by the closing date for the submission of applications.

III. QUALIFICATIONS

Candidates should -

- A. possess a degree in Law from a recognised institution <u>or</u> an equivalent qualification acceptable to the Public Service Commission; and
- B. be computer literate.

NOTE

- 1. Candidates should produce written evidence of knowledge claimed.
- 2. The onus for the submission of written evidence of knowledge claimed and equivalence of qualification (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests with the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 3. Candidates may be required to take part in a written examination.
- 4. The Commission reserves the right:
 - (i) to convene **only** the best qualified candidates for interview; and
 - (ii) not to make any appointment following this advertisement.

IV. ROLE AND RESPONSIBILITIES

To be responsible for the provision of timely and up-to-date research regarding legal issues.

V. DUTIES AND SALARY

- 1. To assist -
 - (a) law officers in carrying out research work related to court cases, legislative drafting and legal advisory work generally;
 - (b) the Solicitor-General and law officers in doing preparatory work prior to participating in conferences, negotiations or discussions relating to the conclusion of bilateral or international agreements or conventions;
 - (c) in producing publications, pamphlets or booklets on specific laws and publication of legal literature; and
 - (d) in the drafting of reports under International Conventions including Human Rights Convention.
- 2. To use ICT in the performance of his duties.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Legal Research Officer/Senior Legal Research Officer in the roles ascribed to him.

The permanent and pensionable post carries salary in scale Rs 27,400 x 825 – $35,650 \times 900 - 37,450 \times 950 - 42,200 \times 1,300 - 46,100 \times 1,575 - 49,250 \times 1,650 - 54,200 \times 1,700 - 64,400 \times 1,800 - 69,800$ a month.
