Since 1997, this Commission has been replaced by the Disciplined Forces Service Commission with extended responsibilities for the naval, military or air forces, the Fire Services and the Prison Services. It is recalled that the Public Service Commission commemorated its 50th anniversary on 30 May 2005.

On this occasion, it is fitting that we renew our tribute and express our sincere gratitude to all the former Chairpersons and Commissioners who served these two Commissions selflessly and with dignity over the years.

These two institutions (the PSC and the DFSC) have, over the last five decades, been upholding important values of our democratic society.

At this juncture, the Civil Service has embarked on administrative reforms, which we earnestly hope will come to fruition. Change means new challenges and necessary adaptation.

We must be careful, however, to make sure that 'administrative reforms' should not mean departing from the fundamentals which have been established by the Constitution.

As constitutional institutions, the Commissions will therefore pursue their work with due respect to the principles vested in them by the country's Constitution i.e. independence, equality of opportunity, impartiality and fairness.

Finally, I sincerely hope that the information contained in this Annual Report will help towards a better understanding of the role and work of the Public Service Commission and of the Disciplined Forces Service Commission.

Executive Summary

The aim of this Report is to apprise the public in general about the activities undertaken by the Public Service Commission and the Disciplined Forces Service Commission during 2008.

This Report lays special emphasis on the Disciplined Forces Service Commission, as it commemorates the 50th anniversary of the setting up of the former Police Service Commission which came into operation on 28 July 1959. Chapter Two gives detailed information on the historical background and composition of the Police/Disciplined Forces Service Commissions. A brief overview of the three departments comprising the Disciplined Forces namely the Mauritius Police Force, the Mauritius Prison Service and the Fire Services has also been included in Chapter Three of the Report.

The various activities undertaken by the Disciplined Forces Service Commission during 2008 have been covered in Chapter Four. A significant number of vacancies in the Mauritius Prison Service have been filled following selection exercises but the highest number of appointments/promotions was made in the Mauritius Police Force. 416 Police Constables were appointed and around 720 officers were confirmed in their posts. Approval for retirement was conveyed to the appropriate Responsible Officers in respect of 47 officers.

On the other hand, the Public Service Commission dedicated much of its time and effort to fill the vacancies arising in the different Ministries/Departments. Appointments to different posts in the Ministry of Education, Culture and Human Resources, the Ministry of Civil Service and Administrative Reforms and the Ministry of Health and Quality of Life accounted for more than seventy-five percent of a total of 1541 vacancies filled. The filling of vacancies for the posts of Trainee Teacher, Occupational Therapy Assistant and Civil Status Officer consisted some of the major selection exercises undertaken in 2008. In some cases, a large number of applications was received to fill a restricted number of vacancies reported in that particular post for instance Occupational Therapy Assistant, Trainee Legal Assistant, Employment Officer, Forensic Technician and Conservation Assistant.

Conversely, for a few posts such as Trainee Teacher (Mandarin), Catering Supervisor (Ministry of Health and Quality of Life and Police Department) and Specialist (Dental Services Orthodontics), among others, there were no qualified candidates or only a limited number thereof.

As regards selection exercises in respect of the various grades on the establishment of the Rodrigues Regional Assembly, the Commission held interviews in Rodrigues to fill a total of 35 vacancies.

The Commission conveyed its agreement in respect of 51 Schemes of Service and its approval in respect of 157 requests for retirement. With a view to maintaining discipline in the Public Service, the Commission also considered various disciplinary cases and inflicted punishments under various Regulations in 63 cases.

CHAPTER TWO The Disciplined Forces Service Commission

2.1 Historical Background – The Police Service Commission

Fifty years ago, the Police Service Commission had been set up on 28 July 1959 by the Mauritius (Constitution) Order in Council, 1959 (G.N. No. 941 of 1959). It consisted of a Chairman and four members

The Police Service Commission assumed executive powers under the provisions of the Schedule to the Mauritius Constitution Order, 1966 (G.N. No. 7 of 1967) with constitutional responsibility for the recruitment of members of the Police Force and for the appointment, promotion and disciplinary control and removal from office of persons of the Police Force.

In the exercise of the powers vested in it by Section 118(1) of the Constitution, the Police Service Commission had enacted its regulations namely the Police Service Commission Regulations, 1967 on 12 August 1967. These had first been published as G.N. No. 77 of 1967 and subsequently amended on several occasions in the years 1972, 1977, 1981, 1982, 1986, 1991 and 1992.

The composition of the Police Service Commission with executive powers when it had been set up for the first time in 1967 was as follows:-

Chairman : Mr N.A.C. WEIR

Members : Mr I.G.G. SMITH

Mr H.R. VAGHJEE

Mr A.M. OSMAN

Mr G. LITINGYING

2.2 The setting up of the Disciplined Forces Service Commission

In its Report on the Public Service Commission dated August 1996, the Standing Committee on Reforms in the Civil Service chaired by Sir D. Burrenchobay had recommended, *inter alia*, that the Police Service Commission be replaced by a Disciplined Forces Service Commission (DFSC) which would deal with appointment, promotion and disciplinary matters relating to the disciplined forces as defined in Section 111 of the Constitution, that is:-

- (i) a naval, military or air force;
- (ii) the Police Force;
- (iii) a Fire Service established by any law in force in Mauritius; and
- (iv) the Mauritius Prison Service.

Consequently, the Constitution of the Republic of Mauritius was amended in May 1997 to give effect to the replacement of the Police Service Commission by the Disciplined Forces Service Commission (Act No. 5 of 1997). Members of the Disciplined Forces Service Commission were henceforth to be known as Commissioners.

2.3 Composition of the Disciplined Forces Service Commission

In accordance with Section 90(1) of the Constitution, the Disciplined Forces Service Commission comprises the Chairman of the Public Service Commission as Chairman and four Commissioners. All of them are appointed by the President of the Republic after consultation with the Prime Minister and the Leader of the Opposition.

Since 1 August 2005, the Disciplined Forces Service Commission, comprises the following Commissioners who have been appointed for another term of office for 3 years with effect from 1 August 2008:



Mr. Régis YAT SIN, C.S.K., B.A. Hons (London). Joined the Administrative Cadre at the Ministry of Finance in 1966. Professional training at the International Monetary Fund Institute, Washington (1969-70) and the Institut International d'Administration Publique, Paris (1973). Promoted as Principal Assistant Secretary in 1975. From 1982-95, served as Permanent Secretary in various Ministries including the Ministry of Agriculture and the Ministry of Industry & Technology. In 1995, became Secretary to Cabinet and Head of Civil Service. Retired in January 2001.

Mr. R. Yat Sin has served as Chairman of various Boards of Directors including the Mauritius Housing Corporation, the State Bank Ltd. and the Airports of Mauritius Ltd. Appointed Chairman of the Public and Disciplined Forces Service Commissions in August 2005, he also sits as member on the Judicial and Legal Service Commission and the Board of Directors of the Mauritius Institute of Education.



Mr Bawanydehal **DOOLHUR**, P.D.S.M joined the Public Service in 1962 as Clerical Officer. After occupying various posts, he was appointed Permanent Secretary in which capacity he served in several Ministries. He retired from the service in January 2004 in his capacity as the Responsible Officer of the Ministry of Social Security.



Mr Ardill **GHANTY** holds a B.A (Hons) in English (Calcutta University), a PGCE at Makerere University and a Dip Ed (ELT) at Exeter University. Appointed as Education Officer in 1972 he was Tutor at Teachers' Training College till 1982 where he was involved with the teaching of English Methodology. He was appointed Principal, State Secondary Schools in 1986 and Rector in 1992. He retired as Rector of Royal College Port Louis in May 2004. Has been Commissioner of the Disciplined Forces Service Commission since 1st August 2005.



Mr Marie Jacques Daniel MARION, M-ès-L and P.G.C.E joined the public service as Education Officer at John Kennedy College in 1977. He was Deputy Rector at Sir Leckraz Teelock SSS and Emmanuel Anquetil and retired as Rector of John Kennedy College in December 2004. He was also member of the Mauritius College of the Air, the Private Secondary School Board and the Mauritius Education Development Company Limited.



Mr Iswar **RAJKOMAR**, BSc(Hons) Agriculture (Udaipur), Post Graduate Certificate in Temperate Horticulture (Australia), MSc Crop Science (Saskatchewan). Joined the Ministry of Agriculture & Natural Resources in February 1967 as Agricultural Cadet and retired in August 2004 as Chief Agricultural Officer. During that period he has also, *interalia*, served as Vice Chairman of the Agricultural Marketing Board, General Manager of Le Val Development and Director, Sugar Insurance Fund Board

2.5 Powers of the Disciplined Forces Service Commission

The Disciplined Forces Service Commission is, by virtue of Section 91 of the Constitution, vested with the powers to appoint persons to any office in the disciplined forces, to exercise disciplinary control over them and to remove such persons from office.

Under the powers vested in it by Section 118(1) of the Constitution, the Disciplined Forces Service Commission made its regulations, the DFSC Regulations 1997, for regulating and facilitating the performance of its functions under the Constitution. Amendments have been brought to the DFSC Regulations in 1998 (G.N. No. 38 of 1998). In accordance with the provisions of Section 118 (4) of the Constitution, the Commission shall not be subject to the direction or control of any other person or authority in the exercise of its functions.

Under the powers vested in it by Section 91(2) of the Constitution of the Republic of Mauritius, the Disciplined Forces Service Commission has delegated the power of disciplinary control in respect of officers of a certain level in the Police Force, Prisons Department and Fire Services Department to the respective Responsible Officers of the Disciplined Forces concerned.

CHAPTER THREE The Disciplined Forces

The Disciplined Forces Service Commission is vested with powers to undertake its functions in respect of members of the Disciplined Forces namely the Mauritius Police Force, the Fire Services and the Mauritius Prison Service.

Whilst the Commissioner of Police is the Responsible Officer for police officers posted to Rodrigues, the Island Chief Executive of the Rodrigues Regional Assembly is the Responsible Officer for officers on the establishment of the Rodrigues Regional Assembly for Prisons and Fire Services in Rodrigues.

The ensuing paragraphs provide a brief overview on the different departments of the disciplined forces and their functions.

3.1 Mauritius Police Force

The Mauritius Police Force is headed by the Commissioner of Police. The present holder who has been appointed on 4 July 2008 is Mr Dhun Iswur RAMPERSAD.

The present workforce of the Police Force stands around 13000.

The duties of the Mauritius Police Force are prescribed under Section 9 of the Police Act (No. 19 of 1974) and are as follows:-

- (a) Preserving the public peace;
- (b) Preventing and detecting offences;
- (c) Apprehending persons who have committed, or who are reasonably suspected of having committed offences;
- (d) Regulating processions and gatherings on public roads and in public places or places of public resort;
- (e) Regulating traffic and preventing or removing obstructions from public roads;
- (f) Preserving order in public places and places of public resort, at public gatherings and assemblies for public amusement;
- (g) Assisting in implementing health, quarantine, customs and excise laws;
- (h) Assisting in preserving order in ports, harbours and airports;
- (i) Executing process issued by any Court;
- (j) Swearing information and conducting prosecutions; and
- (k) Performing such other functions as may be conferred on Police Officers under any other enactment.

3.2 Mauritius Prison Service

The Mauritius Prison Service is headed by a Commissioner of Prisons. The present holder, Mr Lingamanaiker VIJAYANARAYANAN was appointed on contractual basis for 2 years with effect from 13 July 2006. His contract was renewed for another term of two years in July 2008. The present workforce of the Mauritius Prison Service stands around 1200.

The Mauritius Prison Service operates under the aegis of the Prime Minister's Office. It is responsible for keeping prisoners in custody, maintaining order, discipline and safe environment, providing decent conditions for prisoners and meeting their needs including medical care as well as giving advice on and helping with their personal problems. It is also responsible for providing positive regimes which help prisoners to address their offending behaviour and to prepare them to live a full and responsible life thus helping towards rehabilitation of detainees

3.3 Fire Services

The Fire Services Department is headed by a Chief Fire Officer. For the period covered by this report, Mr Rajcoomar RAM has been the Responsible Officer of the Fire Services Department since 25 March 1998. The present workforce of the Fire Services stands at around 800.

The Fire Services Department operates under the aegis of the Ministry of Local Government. Its mission is to protect life and property against destruction by fire, render humanitarian services, give advice on fire prevention and protection measures, and provide support in rescue operations during natural calamities and major accidents both in Mauritius and in Rodrigues. It also aims at detecting and reducing/eliminating fire hazards in industrial plants or other establishments; protecting and salvaging goods during and after fires; and rescuing people in fires, cyclones and floods.

Applications were invited from qualified candidates from the general public for enlistment as Trainee Police Constable (Male & Female) on 4 December 2008 and the closing date for the submission of applications was 24 December 2008. **5697** applications were received from male and female candidates in response to the public advertisement (3932 male & 1765 female).

Arrangements were made for the Physical Measurements Test, Verification of Documents and Physical Aptitude Tests of eligible candidates to be held in Mauritius and in Rodrigues in early 2009.

> Promotion to the rank of (i) Inspector of Police/Woman Police Inspector;

(ii) Police Sergeant/Woman Police Sergeant

Applications were also invited by way of a Notice published in the Police Routine Orders from eligible officers who wished to sit for the competitive examinations in connection with the promotion to the rank of Inspector of Police/Woman Police Inspector and promotion to the rank of Police Sergeant/Woman Police Sergeant.

In response to the Police Routine Order regarding the exercise on the promotion to the rank of Inspector of Police/Woman Police Inspector, 1049 applications were received.

As regards the promotion to the rank of Police Sergeant/Woman Police Sergeant, 6196 applications were received.

CHAPTER FIVE The Public Service Commission

5.1 Composition of the Public Service Commission

In accordance with Section 88 of the Constitution of the Republic of Mauritius, the Public Service Commission comprises a Chairman, two Deputy - Chairmen and four other Commissioners. All of them are appointed by the President of the Republic of Mauritius after consultation with the Prime Minister and the Leader of the Opposition.

In 1995, became Secretary to Cabinet and Head of Civil Service. Retired in January 2001.

Mr. R. Yat Sin has served as Chairman of various Boards of Directors including the Mauritius Housing Corporation, the State Bank Ltd. and the Airports of Mauritius Ltd. Appointed Chairman of the Public and Disciplined Forces Service Commissions in August 2005, he also sits as member on the Judicial and Legal Service Commission and the Board of Directors of the Mauritius Institute of Education.

Served in various Ministries including the Prime Minister's Office, Cabinet Office, Ministry of Health and Quality of Life, Ministry of Industry, Commerce and Co-operatives, Ministry of Tourism and Leisure, Ministry of Arts and Culture and Ministry of Youth and Sports. Was appointed Senior Chief Executive in 2005. Retired from the public service in 2007.

5.2 Powers of the Public Service Commission

The Public Service Commission is empowered by virtue of Section 89 of the Constitution to appoint persons to hold or act in any offices in the public service (including power to confirm appointments), to exercise disciplinary control over persons holding or acting in such offices and to remove such persons from office.

Apart from the powers to, *interalia*, recruit, appoint and promote, Section 118(1) of the Constitution also empowers the Public Service Commission to make regulations for regulating and facilitating the performance of its functions. Section 118 (4) provides that the Commission shall not be subject to the direction or control of any other person or authority in the exercise of its functions.
